Objection - Approved

Hamsey Parish Council objects to this proposal on the grounds that the extension to the main barn is an alien feature which disrupts the integrity of the listed barn and its historic relationship with the grade 1 listed church opposite, to the detriment of the historic character and appearance of this historic area, further domesticating the context of the church and its surroundings.

Hamsey Parish Council notes the minor revision made to these proposals, but we sustain our strong objection to these works on the grounds that they detract from the listed barn by modifying its form from the simple barn structure to an increased domesticated appearance. In form and detail this library extension also detracts from the extremely historic setting of the cherished grade I Church, which should as far as possible demonstrate a historically agricultural, not domestic context.

SDNP/22/05804/LIS Hamsey Place Barn, Old Church Lane, Hamsey

Extension to existing barn and byre. Various internal and external works to include new window and door fitting and roof light openings.

LW/23/0119 Two Ways Bevernbridge South Road South Common South Chailey.

Demolition of existing bungalow and workshop, creation of two pairs of semi-detached three bedroom dwellings. (4 units). Amended plans.

Demolition of Atcost barn and two grain silos, erection of 4 3 bedroom houses. Amended plans.

(c) New Applications

LW/23/0417 - Land West of A275, South Chailey

In addition to the above Hamsey Parish Council have objected to this application which is situated in the Chailey Parish but close to the Hamsey Boundary.

The objection is as follows:

Hamsey Parish Council objects to this planning application. We object because, like Chailey and other rural parishes in this District, we suffer from the same relentless threat to our communities and the countryside from the inexorable pressure of housing development. contrary to properly made statutory plans. Like Chailey, Hamsey invested time, effort and commitment from the whole community on its neighbourhood plan, having been encouraged to do so on the promise that local commitment would provide local control. Like Chailey, our plans are positive, and embrace the growth required of us by Lewes District Council. To discard this investment after a shelf life of only two years is insulting to all who participated. Nor do we lay the blame on LDC, who have also been given the impossible task of preparing complex plans for sensitive and complex areas in unrealistic time scales, and now face monstrous housing targets whose impact has not been assessed and is therefore unknown. We genuinely support the need for housing, but the pressure of development at this scale is more closely aligned to the interests of the volume housebuilders than local communities. It is not unusual for sites with permission not to be implemented because more value can be achieved by leaving land undeveloped and waiting for prices to rise - thus making the resultant housing less affordable for local people.

If the development does progress, either by approval by LDC or on appeal, we would encourage a contribution from the site towards the cycle link proposed as part of the Hamsey Neighbourhood Plan from Chailey to Lewes. We consider such infrastructure necessary to support alternative means of access to and from the site.

Appendix 2 – Councillor's Reports

Report from Cllr. Lindsey Bell for the Parish Council meeting on the 14th September 2023

Chalk Pits / Curry Cottage

I have been looking into the Situation at the Chalk Pits / Curry Cottage. I compiled a report in July regarding the rundown appearance of the buildings and surrounding areas. This report was circulated to members of the parish council and also to Tom Collins who is the senior caseworker for planning enforcement on the South Downs National Park. I sent an e-mail to him updating him on the condition of the building and also the tunnels which have been, since 2013, grade two listed. On the 14th of August I asked Tom for an update and received an e-mail back saying that the neighbourhood first team had been to visit to gather evidence and photos, he has also drafted documents for a Notice, should he not get any response from the freeholders. A second warning letter will be sent if no reply is received from his first letter (to date nothing has been received), a formal action against them can then be taken. I remain In contact with him.

15 Downsview, Cooksbridge

I investigated the fence which is falling down between the station and Malthouse Way, to the right of the footpath. This fence is in a bad state of repair and is being pushed over by the trees which are growing in the garden of the property. A letter has been sent to the owner of the property but to date no reply has been received. A discussion is needed as to how we move forward with this situation before the fence becomes dangerous.

Ploughing of footpaths within the parish

In August there were reports on the Hamsey Facebook page that's footpaths that lead from behind Chandlers Mead up to Hamsey Manor had been ploughed out. On investigation all the margins of the fields have been ploughed out up to the hedge lines. I did a walk along these ploughed footpaths and took photos to establish but it was also designated footpaths that had been ploughed, which is was. I then made a report to East Sussex who have a dedicated page entitled "report a problem with a right of way". By law these footpaths should be reinstated within 14 days of ploughing over them.

I also made a report regarding the state of the footpath that runs over the fields beside Fishpond House towards Lower Tullys Wells. The start of this footpath is now so overgrown that it is almost impossible to use. I have taken photos and video evidence of the state of this footpath. Footpaths should be maintained by the landowner to a width of 1.5 metres. I have also made a report to East Sussex regarding this right of way.

The notice board in Offham

In July I put a notice on the board in Offham and also a post on Facebook asking residents of Offham if they still required their notice board. I received several communications indicating that the notice board was used and appreciated and that it should remain. It should be noted that the current notice board is in a very poor condition and that it is difficult to open the doors and it leaks.

I had a conversation with Chailey parish council and asked them who they used for their new notice boards. These are very smart wooden notice boards that have been put up in South Chailey and North Chailey. They used a local company based in Sheffield Park and said that this company came back with the lowest quote and that they were very happy with the new noticeboads. The general consensus among residents in Offham is that the notice board should be replaced with one in keeping with the village especially as there are a few grade two listed properties in the area.

Magazine deliveries

A resident in Offham contacted me with regards to the delivery of the Hamsey parish council magazine. They were concerned that they and a number of other properties were not receiving the magazine on a regular basis. I have been in contact with Moira who does a brilliant job delivering the magazines in Offham and she has said that she does deliver to all the properties but that she will double check that all houses are covered. She also told me that on her last delivery she was bitten by a dog at a property. I have said to her that on no account is she to deliver to properties where she feels uncomfortable or threatened. She is happy to continue delivering the magazine. However I will include several properties, on my delivery round, that she is unable to do.

Harvest festival October 2023

I have offered to help with a food collection on behalf of the parish for the harvest festival service at Saint Peters in Offham, details to be finalised.

Cllr. Minty Cadwallader Report for meeting Sept 14th 2023

Action - Drive in cinema

August I looked into the potential of holding an open air Cinema night at Beechwood Hall on the 26th of August. Weather dependent and timing based on sunset. Seems like a fun night to be had. 26th of August was postponed to next year. Date to be confirmed.

Action added to canva and prepare flyers for residents at old Hamsey lakes

Flyer 1

I prepared a flyer which was passed round to all the residents in old Hamsey Lakes regarding the Bevernbridge sign. A colour pigment was taken from an old brick from old brickworks Lane and used against the Pantone book to find a relevant colour, helping to give the area some identity. Feedback has been mainly good apart from one or two comments. A request for a slightly different colour has now been requested and we are waiting on the Pantone number so we can run the flyer again. The most common feedback has been more about the name Bevernbridge, which many of the residents don't relate to and prefer calling at old Hamsey lakes or old Hamsey Brickworks . Many residents believe they live in South Chailey, due to the fact that it is on their postal addresses.

Flyer 2

In the process of completing a flyer to help residents know what's going on. Features planning applications of Lakeside development and Knights court development. Unit 3 community hub, Forest (lost woods, project) play area and bus shelters. First draft to be reviewed shortly.

Interesting to note while looking at planning applications for Knightscourt LW12/0622 there has been nine applications for discharge of conditions this year. All have been approved apart from 1 to do with contamination.

Children's play area discharge of conditions 6 approved 3rd July 2023,

Discharge of condition. 18 Air quality measures approved 18th of April 2023

Discharge of condition 8, ecological buffer approved, 3rd July 2023,

Cllr Kate McBrown - Report for HPC meeting September 14th 2023

It's been a quiet period since the last meeting, not much to report apart from the following:

Highways and Traffic issues

Upcoming works to note:

- Network Rail shall be carrying out works at Cooksbridge level crossing, Cooksbridge Road A275 from 13th September 22.00 – 15th September 06.00. Two-way traffic signals shall be in place.
- Drainage investigations to be carried out on the B2116 on 14th September 2023, 09.30 16.00. Two -way traffic signals shall be in place.
- Excavate, investigate and repair footpath void on path adjacent to Covers, Cooksbridge Road from 18th September 9.00- 19th September 15.00. Two-way signals in place.
- Temporary 15 minute delays likely at Hamsey level crossing, The Drove on 8th Oct between 08.00-17.00.
- The Drove, Hamsey Road closure to allow Network Rail to carry out essential rail works from 13th Oct 23.59 16th Oct 05.00. Diversion in place.
- North End Lane Road closure in place to allow BT to carry out works to excavate and replace 1 existing pole in verge to facilitate overhead spine cabling works from 17th October-18th October.
- Lewes Bonfire Celebrations, 4th Nov 16.00 5th Nov 01.00 Road closures in place from Landport fork A275 to include Hamsey Lane and The Drove.
- Road closure to allow South East Water to carry out maintenance and repair works on Whitfeld Lane with diversions in place. 6th Nov 08.00 – 9th Nov 17.00.
- Road closure in place on Town little worth Road, 28th-29th Nov, diversions in place to allow road works to be carried out.

Rail and Bus issues

I attended a GTR Summer Stakeholders drop-in session in London with Ian Ginn on behalf of the Station Partnership on the 31st August. We travelled up by train to King Cross via Cooksbridge then Haywards Heath. We were introduced to the CEO of GTR. We discussed the knock- on effect of the ticket booth closures and I plucked up the courage to chat to the CEO to request that our ticket machine at Cooksbridge station be repaired as soon as possible to which he agreed. It was a pleasure to speak to other members of GTR. I asked when the applications for the Rail community grant would be open for us to apply but unfortunately, there's a back log from last year's applications which has had a ripple effect to this years. We were invited along to another Stakeholder event based around community on 22nd September but as of yet still waiting for the details to be confirmed.

The next Station Partnership meeting is scheduled for Tuesday 26th September at 19.30.

Police/Neighbourhood issues

No matters have been reported to me since the last meeting. I'm waiting for PCSO Rose Stainer to confirm availability for the Police Community Enforcement Van to attend.

Cllr Amanda Sanders, September 2023

It has been a quiet time since the last meeting.

The main thing I have worked on has been the Community Library project.
